

**TODD CREEK VILLAGE METROPOLITAN DISTRICT
SCHEDULE OF FEES, RATES AND CHARGES**

Effective: January 1, 2025

1. TAP FEES.

These fees are privilege-of-service fees that a customer must pay before a Permit for service is issued. Total Tap Fees include fees for: a) Water Connection and Infrastructure Fee; b) Water Resource Fee; and c) Capital Construction Reserve Fee. The Term “paired set” refers to a combination of one Potable and one Irrigation Tap.

Billed upon connection to the District's system. This One-Time FTC fee shall be equal to the difference between the Tap Fee that was originally paid and the current Tap Fee.
